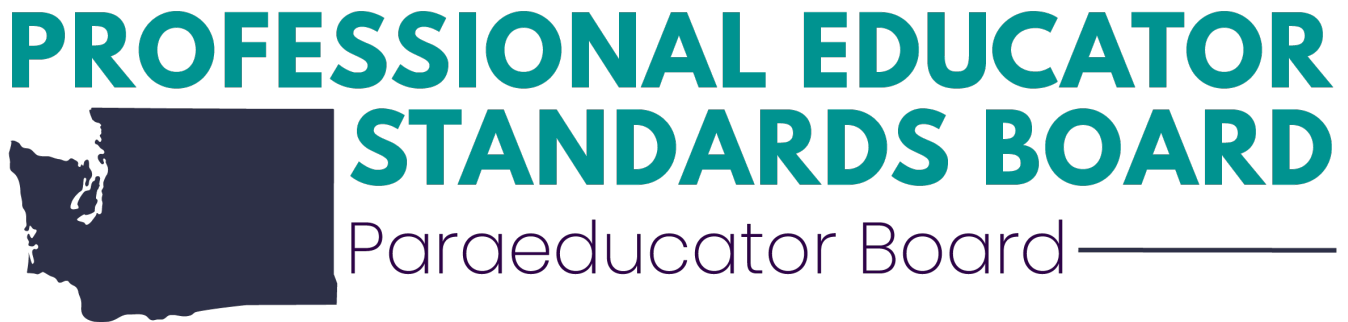


## 2024-25 Paraeducator Training Reimbursement (Form Package 918)

### BEFORE GETTING STARTED

After the Form Package (FP) is submitted and the “Thank You” page appears, a confirmation email with a copy of the submitted data will be sent to the program contact(s) and the authorized assurances official.

### INFORMATION

School districts and ESDs that report\* employing paraeducators must complete Form Package 918 (FP 918). The purpose is to provide a process for school districts and ESDs to report the total number of paraeducators who completed the training requirements for the 2024-25 school year on the Fundamental Course of Study and General Paraeducator Certificate for reimbursement.

*\*The S-275 report from OSPI is utilized to determine the list of eligible school districts and ESDs.*

## REIMBURSEMENT PAYMENT INFORMATION

Reimbursement rate for 2024-25 year is not finalized but will not be less than \$549 per paraeducator for 14 hours of training, and \$1,098 per paraeducator for 28 hours of training.

For **SEPTEMBER 2025 APPORTIONMENT** reimbursement, school districts and ESDs must:

- Have completed all 2024-25 required paraeducator training on or before August 29, 2025.
- Submit completed FP 918 by 11:59 pm on August 29, 2025.

For **OCTOBER 2025 APPORTIONMENT** reimbursement, school districts and ESDs must:

- Have completed all 2024-25 required paraeducator training on or before September 1, 2025.
- Submit completed FP 918 by 11:59 pm on September 23, 2025.

## ASSURANCES

The school district or ESD agrees to the following:

- To adhere to RCW 28A.413 and WAC 179.
- To review and adhere to the Paraeducator Standards of Practice and the Fundamental Course of Study.
- In accordance with the 2025-27 operating budget (SB 5167), the school district or ESD must provide:
  - 28 hours of training on the Fundamental Course of Study (FCS) to all new paraeducators who have not yet received any training; and
  - 14 hours of training on the General Paraeducator Certificate to all paraeducators who have completed the FCS but have not yet completed the General Paraeducator Certificate.
- To only request reimbursement for paraeducators who complete the full training hours assigned to each paraeducator training type.
- To provide paraeducators with written documentation of both FCS unit completion and final completion of the FCS, and the appropriate clock hour forms or documentation for completion of training that meets the general certificate.
- To help the paraeducator upload their completion of the FCS in the E-Certification for Washington State Educators. To adhere to all clock hour or activity-based clock hour procedures and documentation (WAC 181-85).
- To submit final training report for reimbursement by 11:59pm on the following due dates:
  - August 29, 2025 for September Apportionment
  - September 23, 2025 for October Apportionment
